FIGHT TO BRING THE FBI BUILDING TO PRINCE GEORGE'S: President Donald Trump's attempt to block the FBI's relocation to Maryland—an effort widely condemned as prioritizing politics over progress—threatened to derail a transformative opportunity for Prince George's County. Alonzo Washington has already been a leader in the fight to secure the FBI headquarters for Maryland, and he knows what's at stake: 7,500 good-paying jobs for Prince Georgians and \$4 billion in economic activity for our state.
